Essential Care Giver

We are excited to let you know about a program we will be implementing at Cedarwood as our first step towards providing our tenants the additional family support that they have needed this past year. Now that we have had most of our tenants and staff vaccinated, we can begin to look forward to our next steps toward normalcy.

The Department of Health and Human Services in Nebraska have proposed an optional program for assisted livings to help high-risk tenants to receive individualized, person-centered care from family members that previously actively engaged with the tenant. The individuals designated as Essential Caregivers would provide companionship and assistance with basic activities of daily living.

We have established a policy to allow for Essential Care Givers at Cedarwood. Criteria to participate in the program are:

- An Essential Caregiver (EC) must be the individual who previously actively engaged with the resident or who was previously committed to providing psychosocial health support and/or assistance with activities of daily living. Family members who did not provide consistent support or assistance prior to the pandemic would not be eligible for the program. Tenants will generally have one designated EC, in some instances a second EC may be considered.
- To participate in the EC Program, both the tenant and family member must be 2 weeks past completion of their second COVID-19 vaccine. If the tenant or family member do not receive the COVID-19 vaccine, they will not be eligible for the EC program.
- Family members designated as an EC must consent to routine COVID-19 testing, frequency based upon county positivity rate.

Family members designated as an EC will be required to complete facility training must agree to comply with all policies and procedures regarding Infection Control measures while visiting Cedarwood. Failure to comply with Cedarwood policies and procedures may result in suspension and/or revocation of EC program

The Essential Caregiver program will allow for the following:

- Visits that are pre-scheduled for up to 3 hours/day
- EC will be required to wear a procedure mask while in the facility but will allow the EC to be closer then the 6 foot social distancing required with standard visits
- Enable the EC to provide assistance to the tenant with personal needs in the tenants apartment
- Enable the EC to accompany their family member to medical appointments.

My extracurricular activities include: Hunting, Fishing, Hiking, Music, Boxing, Marital Arts, Cars, Motorcycles, Art and Cooking.




